- 1. Complete all requested information in word processed form (see pages 3 and 4 below).
- 2. Submit to South High School Alumni Foundation by **January 31**st, **2024**
- 3. Nominations should be sent to Pueblo South High Alumni Foundation, P.O. Box 1065, Pueblo, Colorado 81002. They may also be emailed to shsaf1959@gmail.com.
- 4. Include at least one letter of recommendation. The letter should stress achievement, leadership, citizenship, and character and meet the criteria of the Foundation.
 - 5. The forms and letters will be retained by the South High Foundation/Alumni Association.
- 6. Factors of race, religion, creed, or sex will not be considered while evaluating candidates for election.
 - 7. The criteria are as follows:
- Recipients must have attended at least one year at and have graduated from South High School.
- Must have been out of high school at least 5 years.
- Inductees must be of strong moral character and standing in Pueblo and the communities in which they have resided. They must continue exhibit good citizenship after induction or face removal from the Hall of Fame.
- Must have significant achievements and/or contributions in academics, business, healthcare, education, non-profit, government, the arts, music, entertainment, or another legitimate area of endeavors as recognized on a city-wide, state-wide, nation-wide, or worldwide basis. Athletic achievement can be considered only after having left South High School. The South High Hall of Champions will continue to recognize athletes for achievements while at South High.
- Recipients must want to receive the award and attend the event unless unable to do so because of unforeseen circumstances.
- Recipients must be willing to pay travel expenses to/from the event unless approved by the board; event proceedings are complimentary to inductee and immediate family. Attempts will be made to mitigate expenses through sponsorship for travel, hotels, etc.
- Recipients must be willing to share their story with the press, the current student body, and to speak briefly at the event sharing their achievements.
- Recipients may receive the award posthumously.

- The recipients should represent the diversity of South High and the Pueblo community.
- There is now no limit on the number of awards but the length of the event may limit the number each year.
- No sitting board member may be a candidate for the Hall of Fame in any of the years he/she serves.
- Faculty, administration, staff, parents, volunteers may be considered even though they have not graduated from South. In this case they must have sound credentials as significant contributors to South and the community at large.
- The Board of the South High Alumni Association/Foundation is solely responsible for selection of the Hall of Fame Recipients and their decisions are final.
- Solicitation of candidates for the Hall of Fame will be made to the community at large, South High alumni, the current student body, etc.
